## **INTRODUCTION**

We, the Executive Board of the Dominica Olympic Committee, Inc. (DOC) are pleased for the opportunity to present to member affiliates of the Committee this report for the year ended December 31, 2001.

The year following the celebration of the XXVII Olympiad was regarded as an election year for National Olympic Committees world-wide. The DOC was no exception, and held its election on April 05, 2001 and new officers were elected.

The majority of the new DOC executive comprises members who belong to National Associations affiliated to their International Federations that are governing a sport on the Olympic Games program. This is in conformity with the provision of the DOC's constitution Section 6 (a) 1, in which "...the number of such member associations shall not be less than five and they shall constitute the voting majority of the committee..." We have also met the mandate of the International Olympic Committee [IOC] of 20% female participation.

## **EXECUTIVE MEETINGS**

In accordance with Section 14 (a) of the constitution, the DOC conducted meetings throughout the Year 2001. It continued to have frequent statutory meetings to address its function and operations. Locally, there were eleven (11) regular meetings, two (2) special meetings and three (3) organisational meetings.

## **ANNUAL GENERAL MEETING.**

The Annual General Meeting of the DOC was held at the Fort Young Hotel on April 05<sup>th</sup>, 2001. All National Associations were invited to be present. Matters raised at that meeting are as recorded in the minutes previously circulated.

## **SPECIAL MEETINGS (Planning Sessions)**

February 11<sup>th</sup>, and September 29<sup>th</sup>, 2001 two special meetings were convened at which the committee met to coordinate plans and goals that [DOC] would adopt in order to assist the National Association affiliated members in advancing their sports on a whole in Dominica.

## **SPECIAL GENERAL MEETING OF AFFILIATES**

The committee met on December 06<sup>th</sup>, 2001 with all National Affiliates for the specific purpose of adopting amendments to the DOC constitution. The DOC's constitution was unanimously adopted. At that meeting the amended Financial Statements and DOC 2000 Annual Executive Report previously circulated were accepted.

During the months of May through July the Executive Board of the DOC met with the Presidents and Secretaries of all National Associations on a sports specific basis for the purpose of determining their future plans and the way forward for their Associations.

## **MEETING WITH THE MINISTER FOR YOUTH AND SPORTS**

The DOC President and General Secretary met the Hon. Roosevelt Skerrit on April 11<sup>th</sup>, 2001 to formally inform him of the composition

of the new DOC executive and to reaffirm [DOC's] commitments for the advancement of sports in Dominica. The Minister spoke of his ministry's role in sport development and his vision as well as the need for collaborated efforts.

## **INTERNATIONAL MEETINGS.**

### **ANOCES MEETING**

To formalize plans of a regional committee of NOCs from the OECS. This meeting was attended by the past president Mr. Felix Wilson on March 17-18, 2001.

### **CACSO GENERAL ASSEMBLY**

On July 17-21, 2001 Mr. Thomas Dorsett attended the General Assembly on behalf of [DOC] in Cartagena, Columbia. Discussions were held in relation to CAC Games to be held in San Salvador in November 2002. Cartagena Organizing Committee was sworn in as the host for the 2006 CAC Games.

### **PASO GENERAL ASSEMBLY**

On August 12<sup>th</sup>-19<sup>th</sup>, 2001 the DOC's President, Rosanne Pringle Pierre and General Secretary, Thomas Dorsett, attended the Pan-American Sport Organisation's [PASO] General Assembly in Santo Domingo, Dominican Republic. The 42 NOCs of the Americas were represented at that meeting. Sites for the upcoming 2003 Pan Am Games were visited. Reports submitted to the DOC executive by both parties highlighted the address made by IOC President, Jacques Rogge at the opening of the assembly.

## ***COMMONWEALTH GAMES FEDERATION GENERAL ASSEMBLY***

The Commonwealth Games Federation held its General Assembly during the period July 25-29, 2001 in the City of Manchester. The President Mrs. Rosanne Pierre represented the DOC at that meeting. Among highlights at that meeting were visits to the venues being prepared for the upcoming 2002 Commonwealth Games in Manchester.

## ***CARIBBEAN CAUCUS MEETING***

The President & Secretary attended a meeting of the Caribbean Caucus of National Olympic Committees held in Port of Spain Trinidad from April 29-May 01, 2001. The main purpose of the meeting was to formalise the establishment of the Caribbean Caucus of National Olympic Committees [CCNOC] by approving the "Declaration of Port of Spain". Currently a constitution for CCNOC is being drafted by the steering committee.

## ***OLYMPIC AND SPORTS VOLUNTEER WORLD CONFERENCE***

The DOC Treasurer Mr. Phillip White attended on behalf of the DOC the World Conference on Olympic and Sport Volunteerism from 12-14 November 2001 in New York. The conference highlighted the benefits of volunteerism and the importance of volunteers for International Sporting events and in Sport and Culture, and Educational in Institutions among others.

## ***DOC OPERATIONS AND ACTIVITIES***

### Olympic Day Run

On June 23<sup>rd</sup> 2001, the DOC once again staged the Olympic Day Run under the theme "Celebrate Humanity" commemorating the 107<sup>th</sup> anniversary of the founding of the International Olympic Committee. A total of 320 runners participated in the event, making it [DOC's] most successful Olympic Day Run to date.

### Volunteer Awards Ceremony

On December 13<sup>th</sup>, 2001 the Dominica Olympic Committee hosted an awards ceremony at the Fort Young Hotel where over one hundred (100) sports volunteers were recognized for their work in advancing sports in Dominica.

## **SUB-COMMITTEES**

Mandated by the International Olympic Committee the DOC commissioned five (5) sub-committees with specific instructions as to their functions, and which must coincide with those of the counterpart commissions set up by the International Olympic Committee. These sub-committees can access special funding and their activities are guided by rules and procedures established by the IOC.

## **DOC's NEW OFFICE.**

## **FINANCIAL POSITION**

At the end of the financial year ended December 31, 2001, the DOC was happy to report a positive cash balance of EC\$293,079 an increase of 106% over 2000. Our administrative expenses increased by EC\$23,204.00 from that of 2000 due to new and upgraded office facilities.

The DOC, through its International Donor Agencies, namely; Olympic Solidarity and the Pan American Sports Organization [PASO] makes funding available to its affiliates for the running of courses and the purchasing of equipment.
